The approval process depends on the length of time it takes for your references to respond. On the first order, we suggest Cash Options or Credit Cards to speed up delivery of your order. You will be notified once your credit has been approved and your order can then ship.

{slide=How long is your quote valid?}

All quotes are valid for 24 hours and subject to prior sales. Crystal Electronics, Inc. Pricing on hard to locate components is based on the existing market conditions including supply and demand.
